What Will I Receive Upon Completion?

A Statement of Attainment will be issued by CTI and a High Risk Work Licence will be issued by WorkSafe Victoria, after lodging your Competent Notice of Assessment Online at a cost of \$66.60.

What Content is covered in the Training?

This course describes the skills and knowledge required to operate a personnel and materials hoist including: planning the work, conducting routine checks of the personnel and materials hoist, conducting hoist operations and shutting down and securing the hoist.

Units

Participants need to complete one unit consisting of:
Licence to operate a personnel and materials hoist

Who Can Undertake the Training?

Students are required to be over 18 years old, competent in written and spoken English and will undertake a Language, Literacy, and Numeracy test prior to commencing the training.

How often do the Courses Run and what is their Duration?

This course is scheduled over 2 session (16 hours) undertaken in 2 days and includes pre learning.

Courses are run regularly throughout the year. Please speak to directly to Construction Training International for exact course dates.

Normal operating hours are 7am-5pm.

How is the Course Trained and Assessed?

All students will be required to undertake pre-course reading to ensure an understanding of the learning content that will be reviewed in the class contact time.

One enrolled into the course, students will be provided the Learner Guide and are required to read this guide prior to attendance.

Training and assessment will take place in RTO's training rooms by a qualified Trainer monitoring your progress.

CONSTRUCTION TRAINING INTERNATIONAL P/L

The course is delivered with both theory and practical elements and is completed via a simulated work environment. The delivery of training will include a mixture of classroom delivery, group discussions and individual research.

Assessment is used to provide you with feedback on your progress and to measure your skills and knowledge against the training qualification requirements and those of the industry. The assessment process may include written questions, case studies and practical demonstrations.

How Much Will it Cost?
