CTI uses industry authorised Assessment Instruments and the Unit of Competency is nationally recognised. All of our Assessors are qualified with industry experience and appropriately licenced.

What does the course cover?

This course gives you the skills and knowledge required to operate a slewing mobile crane (over 100 tonnes) including: planning the work, conducting routine checks, setting up the crane, transferring loads in a safe manner, mobile loads, and shutting down and securing the crane.

Who Can Undertake the Training?

Students are required to be over 18 years old, competent in written and spoken English and will undertake a Language, Literacy, and Numeracy test prior to commencing the training.

Course Pre-requisites

A Pre Requisite of this course is Dogging.

You will need to obtain a USI (Unique Student Identification) number. If you are under the age of 25 years old, your VSN (Victorian Student Number) will also be required.

A Student Enrolment Form and a Pre Training Review Form will need to be completed prior to attending. PPE and appropriate clothing is required to be worn.

Course Pre-learning requirements

On enrolment, you will be sent some Pre learning in the form of a workbook that will need to be completed prior to attending.

Funding:

We offer Eligible students Government subsided Training.

This training is delivered with Victorian and Commonwealth Government Funding and we encourage individuals with disabilities to access government subsided training.

In 2016 you are eligible for a Government Subsided training place if you are:

An Australian Citizen

An Australian Permanent Resident (holder of a permanent visa)

A New Zealand Citizen

And are any of the following:

Under 20 years of age

Seeking to enrol in an approved Foundation Skills List Course

Seeking to enrol in VCE or VCAL

Seeking to enrol in an apprenticeship

20 years & older and upskilling by seeking to enrol in a course at a higher level than your existing qualification.

How is the Course Trained and Assessed?

Training and assessment will take place in RTO's training rooms by a qualified Trainer monitoring your progress.

The course is delivered with both theory and practical elements and is completed via a simulated work environment. The delivery of training will include a mixture of classroom delivery, group discussions and individual research.

Assessment is used to provide you with feedback on your progress and to measure your skills and knowledge against the training qualification requirements and those of the industry. The assessment process may include written questions, case studies and practical demonstrations.

How often do the Courses run and what is their Duration?

This course is delivered over 4 consecutive days (8 hours per day).
